## **New York State Needs a Comprehensive State Approved Holocaust and Other Genocide Education Curriculum**

As the year 2020 fades into the sunset, many are noting a glaring rise in anti-Jewish sentiment.

Whether on the streets Brooklyn or on college campuses, Jews are targeted just for being Jewish. A recent survey revealed that 8 out of 10 American Jews feel that anti-Semitism in the US is getting worse. (Source: The Conference on Jewish Material Claims Against Germany.)

It's beyond dispute - anti-Jewish incidents are increasingly common, but when asked, shockingly, most non-Jews don't think the hatred of Jews is increasing. In fact, many Americans aren't even sure what constitutes anti-Semitism. And 7 out of 10 Americans say fewer people seem to care about the Holocaust than they used to, even though a majority (58%) believe something like the Holocaust could happen again.

It's up to us to Educate to Stop Hate!

New Yorkers have a wide-open door of opportunity to bring the power of that truth back into the spotlight. This opportunity has been ours since 1994, when a law was passed that required Holocaust education to be included in public schools in New York and New Jersey.

Just one problem: while New Jersey schools followed through and instituted a comprehensive State approved Holocaust education curriculum to boost the awareness of bigotry in young and impressionable minds, New York educators never established such a curriculum. In 2014 NYS did create a limited curriculum that was moving in the right direction but it was left up to the 732 individual school districts and over 4700 schools to follow through.

It's time for Albany to fix this nightmare. A State sponsored Holocaust education curriculum

would close the gap in this story. It would contrast this dark chapter of human history with the heroism that humankind can show against acts of discrimination. It would help children and their families learn the Jews, but any targeted group of

individuals. Let's re-open the door to Holocaust education together in
